### ASSESSMENT AND TREATMENT OF TRAUMATIZED POPULATIONS

#### I. Course Description

The course is designed as an advanced clinical selective for graduate students in the School of Social Work who wish to increase their knowledge and skills for practice with traumatized persons. Students will develop a working understanding of traumatized populations from diverse backgrounds, affirming and respecting their strengths, differences, and challenges. This course is grounded in the identification, analysis, and implementation of best practices in empirically-supported assessment and intervention strategies. It will focus on skill building and will include multiple perspectives in the advanced application of theories, models, and skills utilized in varying treatment modalities, with emphasis placed at the micro and mezzo levels of practice. The framework of the course is based on social work values and the ethical decision-making process, as illuminated by the NASW Code of Ethics.

#### II. Course Objectives

By the end of the semester, students will be able to:

1. Be aware of the varying definitions and types of trauma and the prevalence rate in our society;
2. Identify steps practitioners can take to prevent or ameliorate their own vicarious or secondary trauma and that of their colleagues;
3. Understand assessment in support of the diagnosis of trauma- and stressor-related and dissociative disorders, one of which is Posttraumatic Stress Disorder (PTSD);
4. Recognize the challenges of assessing trauma due to comorbidity and the impact of trauma on persons with and without co-occurring disorders;
5. Develop trauma assessment skills using empirically-based assessment approaches and instruments;
6. Demonstrate understanding and skills in the core components of the treatment of trauma, such as the therapeutic relationship, psychoeducation, and treatment stages;
7. Gain practice in using techniques to increase client safety and reduce arousal;

8. Describe the key features distinguishing among several evidence-based treatment approaches for PTSD and trauma-related symptoms;
9. Demonstrate skills in at least one trauma treatment modality;
10. Choose, tailor, and integrate appropriate and evidence-based clinical interventions based on the context in which they are delivered and with respect for diverse populations; and
11. Demonstrate advanced knowledge of social work values and ethical decision-making processes as they relate to ethical dilemmas in clinical intervention with traumatized persons.

### **III. Teaching Methods**

This class provides opportunities for development of both theoretical thinking and clinical skills. Learning takes place through a combination of readings, lectures, videos, small group exercises, demonstrations, case studies, role playing, guest speakers, discussion boards, and in-class discussions. Each student is expected to contribute as appropriate. Students will be expected to have done the assigned readings before class. *All in-class discussions related to personal values, beliefs, or life experiences will be kept confidential.*

### **IV. Texts**

*There are no required texts for this course.* A variety of readings will be assigned throughout the semester. These are accessible in Canvas, either as files or as links to UT library resources.

### **V. Course Requirements**

The grade for this course will be based on the student's ability to demonstrate knowledge and skills related to trauma assessment and treatment, as well as on the student's degree of *active* involvement in learning (i.e., class readings, informed discussion, and experiential exercises.)

#### ***My Maintenance Self Care Worksheet***

**Due: September 1**

**5 points**

Students will complete a self-care self assessment worksheet and submit it through Canvas.

#### ***Reading Reflections***

**Due: Six of eight various dates (see syllabus)**

**30 points**

Students will complete a short reading response (about 300 words) to a set of questions related to the assigned readings. The responses will be submitted through Canvas. Each response will be worth a total of five points. Students may complete more than six reading responses, in which case the highest six grades will be counted.

### ***Online Training and Creating a Handout***

**Due: handout October 20, online training December 1**

**20 points**

There is free online training available at the website for the Medical University of South Carolina. You may choose to focus on TF-CBT, which directly addresses working with children although the principles are applicable to anyone, *or* to focus on CPT. These 10-hour courses train you in the basics of using these models, which are both widely accepted in the profession. You choose one model and complete the course for 10 points credit. Print and bring the certificate to class for credit or submit it through Canvas. If you do not complete the entire course, you will be awarded one point for each hour you completed. The second 10 points will be awarded for participation in creating a handout describing your chosen method, TF-CBT or CPT. This handout will be created in Canvas, collaboratively by all students who trained in that method.

### ***Team or Individual Case Study and Feedback to Peers***

**Due: case study November 10, feedback November 17**

**30 points**

This written assignment may be completed individually or in teams of two. For the team grade, both parties will receive the same grade (for the 25-point paper). In the case in which teammates contribute unequally and are unhappy, the grade may be adjusted individually to reflect each person's contribution.

Students will choose a case from the list on Canvas. The case is due near the end of the semester, however, much of the paper can be written earlier and students are encouraged to start early.

25 of the 30 points will be awarded based on the paper and the remaining 5 points will be awarded individually based on the quality of each student's feedback to their classmates' case studies.

### ***Treatment Comparison***

**Due: November 3**

**5 points**

Students will create a treatment comparison worksheet, comparing and contrasting several trauma treatment modalities, including Accelerated Experiential Dynamic Processing (AEDP), Trauma-Focused Cognitive Behavioral Therapy (TF-CBT), Cognitive Processing Therapy (CPT), and Eye Movement Desensitization and Reprocessing (EMDR). The worksheet will be submitted through Canvas and will be graded only for completion, not for content.

### ***Class Attendance and Participation***

**Due: December 1**

**10 points**

Regular attendance and participation in class activities and discussion is important for your learning. If you have any circumstances that prevent attendance or participation, please inform the instructor as soon as possible.

**Extra Credit**

**Due: December 1**

**up to 2 points**

There is a list of approved Extra Credit opportunities that offer online training or education in topics related to trauma. Please suggest any additional opportunities that you find. Each hour of training equals one extra credit point. Please obtain a completion certificate if possible or other documentation. If you don't have any documents, then write a paragraph about the topic and what you learned. You may earn up to two points total.

## VIII. Class Policies

**UNANTICIPATED DISTRESS.** Students may experience unexpected and/or distressing reactions to course readings, videos, conversations, and assignments. If so, students are encouraged to inform the professor. The professor can be responsive and supportive regarding students' participation in course assignments and activities, but students are responsible for communicating clearly what kind of support is desired.
